This is to inform you that the 5th Annual General Meeting (AGM) of Jindal Stainless (Hisar) Limited ("the Company") has been held today i.e. Thursday, 27^{th} September, 2018 at 12:30 p.m. at its registered office at O.P. Jindal Marg, Hisar – 125 005 (Haryana).

Mr. Ratan Jindal, chaired the meeting. The Chairman confirmed the presence of requisite quorum as per Section 103 of the Companies Act, 2013. Thereafter, he called the meeting to order. The Chairman extended a warm welcome to members and other dignitaries present at the meeting. He then introduced the Directors and officers sitting on the dais. Authorized representatives of the Statutory Auditors of the Company were also present at the meeting.

The Members were informed that the Statutory Registers, Proxy Register and other documents referred to in the AGM Notice, were kept open for inspection.

It was further informed that the Notice convening the AGM, Annual Report for the year 2017-18 and other documents were sent to all the members and others entitled thereto through permitted mode. With the permission of the members, the Notice of the AGM was taken as read. The Reports of the Statutory Auditors and the Secretarial Auditors was not required to be read as they did not contain any qualification, observation or comment.

The Chairman in his address apprised the members about performance of the Company and its future prospects. Thereafter, he invited members to ask questions or queries pertaining to the performance of the Company.

It was then informed that pursuant to the provisions of the Companies Act, 2013 read with Rules framed thereunder and the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company had extended remote e-voting facility to the Members of the Company in respect of the Resolutions mentioned in the Notice convening the AGM. The remote e-voting commenced at 9.00 a.m. on 24th September, 2018 and ended at 5.00 p.m. on 26th September, 2018. The Company engaged the

services of Central Depository Services (India) Limited ("CDSL") as the authorised agency to provide e-voting facility and appointed Mr. Kamal Gupta, Advocate, as the Scrutinizer for the purpose of scrutinizing the remote e-voting and ballot process in a fair and transparent manner. The facility for voting through ballot was also made available at the AGM for Members who had not cast their vote earlier through remote e-voting / physical ballot.

4	Special Business	Appointment of Mr. Jagmohan Sood as Director.
5	Special Business	Appointment of Mr. Jagmohan Sood as the Whole Time Director of the Company.
6	Special Business	Appointment of Mrs. Arti Luniya as an Independent Director.
7	Special Business	Reappointment of Maj. Gen. Kanwaljit Singh Thind, VSM (Retd.) as an Independent Director.
8	Special Business	Approval for payment of Commission to Mr. Ratan Jindal, Chairman (Non-Executive) of the Company as per SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended.
9	Special Business	Ratification of remuneration payable to M/s Ramanath Iyer & Co., Cost Accountants, as Cost Auditors of the Company, for the financial year 2018-19.

The Chairman further informed that the Scrutinizer will consider the votes cast through remote e-voting, physical ballot and ballot conducted at the meeting and will then prepare consolidated report of voting on the resolutions and submit to the Chairman. On receipt of Scrutinizer's Report, the Company will send the result to the Stock Exchanges where the shares of the Company are listed within 48 hours of the conclusion of the meeting and shall place the same on website of the Company and CDSL.

The meeting was thereafter concluded at 1:40 p.m. with a vote of thanks to the Chair.
